AFTER SCHOOL CARE INFORMATION**

Briarwood offers the Lion Learning Center for students enrolled in our school for Kindergarten and TK. After School Care is provided when the Lion Learning Center dismisses at 2:20 and after First and Second grades dismiss at 2:20 until 5:30 PM. This service is available only to those who elect to use it regularly. All children who stay for these programs must be registered and have their paperwork on file **before** attending.
We do not accept drop-ins in our After-School Care program

The Lion Learning Center and After School Care programs operate on all full school days and on days the school is closed for conferences (if the child is registered for those days.) It is closed on the days that the school is closed including weather days, school holidays, the last day of school and summer months. You will be notified of any times that our hours will be different from the norm.

The school charges a fixed monthly amount in September through May determined by the scheduled hours the child is registered to use the service, based on the rate chart below. There is a maximum charge of \$320.00 per month for the first child and \$240.00 per month for the second child. The monthly charge is a fixed charge, and it will not change from month to month.

Please note: This service ends each day at 5:30 PM. Your children and our workers desire for you to arrive promptly. Our very reasonable rates will increase at 5:30 PM. We will assess you \$10.00 for the first fifteen minutes after 5:30 and \$1.00 for each additional minute after 5:45 PM.

In order to provide the most secure after-school environment possible for your children, we need your complete cooperation in requiring the following of your children:

1. Every child must report to their After School Care teacher immediately after school.
2. All K4 students will have a time of rest or time to nap. Children in K4 naps must have a mat. We request that the mat be the type that folds together due to space restrictions. No sleeping bags, pillows or blankets, please. The mat may be left at school but we encourage you to frequently take it home, wash it and return it to school.
3. We need to see the person who is picking up each child and they must have the current carpool card with them.
4. All children in the LLC or ASC must be signed out on the sign-out sheet located in the Lion Lobby. An After School Care worker will take those children leaving with the 2:20 or 3:00 carpool to their carpool area.
5. If your child participates in another activity during the time he or she is scheduled for Lion Learning Center or After School Care, we must be informed in writing. A student cannot leave Lion Learning Center/After School Care before time for the activity and the student should return immediately afterwards. Due to the many students that we serve, the school cannot be responsible for getting the children to outside activities such as ballet, piano, soccer, etc. In the Lion Learning Center and After School Care, we strive to maintain a consistent program for the children with the same rules as the school.

We desire to work closely with the parents and keep you informed about any aspect of your child's day in the Lion Learning Center and After School Care. We welcome your call or visit if you should have any concerns about our programs. We want your child to learn and have fun in the Lion Learning Center and After School Care and by working together we hope to achieve this goal.
